Proceedings of the 1st meeting of the reconstituted West Bengal State Social Security Board held on 27.02.2018 at 3-00 p.m. in the Conference Hall of the Labour Department, Government of West Bengal, New Secretariat Buildings, 12th floor, 1, K.S. Roy Road, Kolkata – 700 001.

Hon'ble Chairman and Minister in Charge, Labour Department, Government of West Bengal took the Chair and welcomed the members and other officials present.

The CEO, WBTWSS Scheme reported in the meeting that there were 3, 27,280 number of enrollments under the West Bengal Transport Workers' Social Security Scheme as on 31.01.2018 and an amount of Rs. 98,18,400 has been collected as enrollment fees up to 31.01.2018. Cess collected under the West Bengal Transport Workers' welfare Cess Act, 2010 was Rs. 141, 46, 79,925 up to 31.01.2018. A cumulative amount of benefit of Rs. 67, 70, 61,699 has been given so far to 72,807 beneficiaries.

An agenda wise discussion was initiated thereafter:

1) Approval for compliance with the provisions of SSY - 2017:-

Labour Department, Government of West Bengal vide its notification no. Labr./257/ (LC-LW) dated 03.04.2017 and Labr./698/(LC-LW) dated 12.10.2017 introduced a scheme called Samajik Suraksha Yojana, 2017 (SSY, 2017) w.e.f. 01.04.2017, wherein, inter alia, it has been stated that, transport workers presently registered under WBTWSS Scheme are eligible to be included as beneficiary.

Vide another Labour Department, Govt. of West Bengal, notification no. Labr./255/LC-LW dated 03.04.17, all other provisions of the existing scheme, except clauses relating to benefits such as pension, family pension and cashless medical benefits in case of auto and taxi drivers, have been repealed resulting in the existence of the WBTWSSS in a truncated form.

Benefits presently admissible to transport workers have been modified according to the above mentioned G. O.s.

All types of common benefits and extra benefits are now payable to eligible transport workers as enlisted under SSY, 2017 as noted in the following table:

All such alterations, modifications and inclusions were placed before the Board for apprisal and approval. The above matter was discussed and debated in length and the Board approved of the Scheme of "SSY, 2017".

However, the representative of C.I.T.U. submitted a memorandum of dissent and noted their disagreement in regard of the Scheme of SSY, 2017.
