An agenda wise discussion held thereafter and decision taken as follows:-

Agenda No 1: Confirmation of the proceedings of the 4rth meeting of the Board

The 4rth meeting of the West Bengal State Social Security Board held on 26.09.2019 under the chairmanship of Hon'ble MIC, Labour Department in the Conference Hall of West Bengal Unorganised Sector Workers' Welfare Board, New Secretariate Buildings, 8th Floor. The proceedings of the said myhalait meeting which already had been sent to members was placed for confirmation.

It was discussed and confirmed unanimously.

Agenda No 2: Action Taken Report

As per proceedings of the 4rth meeting Action Taken Report on 1) Amendment of the Scheme in relation to changing of Registering Authority 2) Delegation of delay Condonation power to the ALCs 3) proposal of travelling allowance to the Board members 4) proposal for car hiring rate enhancement was placed before the members of the Board for their kind appraisal.

It was decided that power of Condonation of delay of ALC will be upto one year and thereafter Labour Commissioner may condone the delay in renewal.

Regarding car hiring fees, it was decided that for each RLO Rs. 1500/- per day two days per month and for RLO situated in hilly areas, Rs. 2000/- per day for two days per month would be sanctioned.

Agenda No 3: Approval for pension cases

The Board members were informed that pension for 109 new beneficiaries under WBTWSSS have already been started and PPOs for 111 numbers of beneficiaries have been prepared for starting the pension as per Annexure 'A' and 'B' respectively of agenda note.

The members of the Board accorded post facto approval for these cases.

- 1. It was decided that the toto drivers cannot be enrolled into WBTWSSS as their vehicles are not registered by proper authority but drivers of e-rickshaw can be treated as transport workers and be enrolled under WBTWSSS if their vehicle is registered by proper authority.
- 2. It was decided that Trade Unions can print leaflets on the matter of SSY, 2017 for awareness generation
- 3. It was informed by the Chairman and Hon'ble MIC that the prospective drivers should be encouraged to participate in the free driving training course arranged by the Government, after completion of which they will be provided driving license at free of cost.
- 4. All members were requested to send a stamp size photo and information regarding phone number, e-mail i.d. etc for giving Identity Card.
- 5. Regarding the issue of payment of allowance to Board members for attending meeting, Hon'ble Chairman informed that accepting such allowances by members may be treated as holding an office of profit, which may prevent them specially Trade Union representatives, from contesting any election. So, the issue may be dropped for the present.
