Hon'ble MIC, Labour Department & Chairman of the Board presided over the meeting. Shri Aziz Rasul, Secretary of the Board welcomed all the members present. With the permission of the Chairman, he initiated the discussion as per agenda.

The Secretary of the Board placed before the Board members an Action Taken Report on the decisions taken during the 14th meeting of the Board held on 08.05.2015.

Progress under SASPFUW & WBUSWHSS upto October, 2015 was placed before the Board members. The number of beneficiary enrolled upto October, 2015 is 53,72,951. Status of distribution of 'Samajik Mukti Card' for Unorganised Sector workers covered under SASPFUW was also placed before the Board members i.e. total number of cards prepared since inception upto 31.03.2015 is 29,45,226 and number of cards prepared during the financial year 2015-16 is 1,90,194.

The Board members were also apprised of the status of the activities under computerisation of SASPFUW records upto 30.11.2015 . No. of Form-I digitized & uploaded was 45,23,724 against total no. of enrolment of 53,72,951

The Board members expressed their satisfaction over the performance under SASPFUW and WBUSWHSS. However, they desired that the Board officials will continue their effort in the coming months for better implementation of the schemes

Expenditure incurred for the period from 1.04.2015 to 31.10.2015 was also placed before the Board for post-facto approval. Issues on uniform accounting procedure to be followed by the RLOs and observance of Social Security Month, 2016 in the month of January also came up for discussion
