

Proceedings of the 45th Meeting of the WBB&OCWW Board held on 05.09.2024 at 02:30 p.m. in the Conference Hall, Labour Department, N. S. Buildings (12th Floor), Block - A, 1, K. S. Roy Road, Kolkata- 700 001

The Hon'ble Minister-in-Charge, Labour Department took the chair and welcomed all present in the meeting. The meeting was presided over by Shri Ritabrata Banerjee, Chairperson, West Bengal Building & Other Construction Workers' Welfare Board (the Board). He too welcomed all present and requested the Secretary of the Board to initiate agenda wise discussion. The list of the members, invitees and officials who attended the meeting is annexed herewith.

1. The Proceedings of the 44th Board Meeting held on 13.02.2024 and its Action Taken Report was discussed and confirmed.
2. Separate Audit Reports of the West Bengal Building and Other Construction Workers Welfare Board for the year 2020-21 and 2021-22 were placed before the Hon'ble Board Members. Discussion was held and the SARs thus placed, were approved by the Board Members.
3. Thereafter, threadbare discussion was held on the proposal of amendment of Rule 269, Rule 270 and Rule 271 of the West Bengal Building and Other Construction Workers Welfare (RE & CS) Rules, 2004. The detailed discussions in regard to amendment of Rule 269 and Rule 270 is as stated below :-

After introduction of the Samajik Suraksha Yojana (SSY) vide Labour Department Notification No. Labr./257/(LC-LW)/LW/5M-112/16 dated 3rd April, 2017 and revision of the BOCW Scheme vide notification No. Labr./256/(LC-LW)/LW/5M-112/16 dated 3rd April, 2017 it became mandatory for a construction worker to get himself / herself registered separately in the said two separate schemes respectively through the SSY portal for availing Death benefit, Disability benefit, Provident Fund benefit and through the e-District portal in order to avail Pension benefit. It has been reported by various RLOs that a considerable number of construction workers got registered only under SSY / BM-SSY, but could not get registered under the BOCW Scheme through e-District portal. Consequently, those workers became ineligible for Pension benefit under Rule 276(1) of the WBB&OCW (RE & CS) Rules, 2004. Now, with a view to bringing such construction workers under the coverage of BOCW Scheme with a retrospective effect so that they become eligible for pension, Rule 269 & Rule 270 of the WBB&OCW (RE & CS) Rules, 2004 are required to be amended suitably so that the date of registration under BMSSY can be treated as the date of registration under the Building and Other Construction Workers (Regulation of Employment & Conditions of Service) Act, 1996. The Board Members unanimously agreed to such amendment.

Sri Biblab Bhatta, representative of A.I.T.U.C. apprehended that some beneficiaries who already crossed the age of superannuation for pension benefit in the meantime may not be able

to avail benefit of this amendment. The Hon'ble MIC, Labour Department assured that such cases will be discussed in the next Board meeting(s) for approval.

The Chairperson, WBB&OCWW Board suggested that all the RLOs may be asked to submit a detailed report of such workers, who were registered under BMSSY scheme but failed to register under the e-District and also have completed 5 years in the scheme and already attained 60 years of age. Thereafter, the matter will be discussed and suitable decision will be taken by the Board so that such workers may get the pension benefits.

The Secretary, Labour Department proposed that the Board should also collect information about the workers who got registered under BOCW (RE & CS) Act, 1996 through e-District but did not get themselves registered under the BM-SSY.

Apart from this, it was noted that according to Rule 271(2) of the WBB&OCW (RE&CS) Rules, 2004, with the permission of the Secretary of the Board or any officer authorised in this behalf, the membership of a defaulter beneficiary can be resumed on payment of arrears of contribution subject to the condition that such resumption shall not be allowed more than twice. This condition debars many *bona fide* beneficiaries from receiving pension even if they have been registered under the WBB&OCWW Board for more than 5 years. Therefore, it becomes necessary that the Rule in question be amended suitably so that there remains no bar in resumption of membership if the arrear contribution is paid by the registered construction workers.

This proposal was welcomed by all. However, Shri Ashok Ghosh, General Secretary, U.T.U.C. Central Committee and Invitee of the Board suggested that there should be a rider in this amendment so that only genuine workers may avail of the benefit. The Chairperson of the Board proposed that if a beneficiary commits default in the payment of contribution continuously for a period of five years (one year under the existing rule), he /she shall cease to be a beneficiary of the fund. Everybody accepted this proposal.

It was decided that the WBB&OCWW Board will place this proposal of these amendments through the Labour Department at an early date.

4. The status of different projects in connection with Health Centres, Crèches, Guest House and Hostel/Transit Accommodation-cum-Training Centre was placed before the House. It was reported that the Secretary, Labour Department had already held a meeting with the officials concerned of the North Bengal Development Department in this regard. The Hon'ble MIC, Labour Department informed that following deputation posts will be created under the Tea Directorate so that the Crèches and Health Centres could be managed properly :
 - a) One post of Medical Officer from the H & FW Department.
 - b) One post of Child Welfare Officer from the Women & Child Welfare Department and Social Welfare Department.
 - c) One post of Executive Engineer (Civil) ; two posts of Assistant Engineer (1 Civil and 1 Electrical) ; two posts of Sub - Assistant Engineer (1 Civil and 1 Electrical) from the Public Works Department.

- d) One post of Accounts Officer from the WBA & AS.

The Labour Commissioner, West Bengal and Member-Secretary of the Board apprised all that an Additional Labour Commissioner has already been posted in the Tea Directorate for this purpose.

Sri Biplab Bhatta, representative of representative of A.I.T.U.C. & Member requested the Hon'ble MIC to extend such facilities of crèche and health centres to other districts apart from the North Bengal region. It was noted that certain occupational diseases specifically related to the construction sector needed to be addressed. Therefore, these health centres, once operational, will be very helpful to tackle such ailment of the workers concerned. The Chairperson of the WBB&OCWW Board informed that the crèches and health centres will be constructed in other parts of the state as well through phased manner.

It was resolved that the progress of the construction projects undertaken by the Gorkhaland Territorial Administration (GTA) will be reviewed by Hon'ble MIC, Labour, Chairperson, Board and Secretary of the Labour Department shortly. Shri Ashok Ghosh, Invitee requested the Chairperson and the Secretary of the Board to organize another visit by Board Members to North Bengal in order to review the progress of construction of health centres and crèches.

5. The Board members were informed that a plot of land measuring 1.47 acre under Khatiyani No - 07, JL No - 14, Mouza - Indong Tea Garden, PS - Matiali. District- Jalpaiguri had been transferred in favour of the WBB&OCWW Board. The Hon'ble MIC advised that the PWD should be asked to submit a detailed project report covering civil, electrical and other construction related issues for the Hostel/Transit Accommodation cum Training Centre at Jalpaiguri district.
6. Thereafter, discussion was held on audit observation regarding settling of the following liabilities:
- a) Skill Development: Rs. 17.32 Lakh regarding payment to the agency (Orion Edutech Pvt Ltd.) regarding Skill Development Training of the Construction Workers since 23.09.2016.
- b) Interest on Subscription Account: Rs. 4.35 Crore as interest on Subscription amount since 2020-21 F. Y.
- c) Refund of excess Cess payment regarding :-
- i) Rs. 1,79,320/- in connection with Jasoda Refrigerator Servicing Centre since F.Y. 2020-21.
- ii) Rs. 8,658/- in connection with WB Comprehensive Area Development since F. Y. 2020-21.
- The Board Members agreed that such liabilities will duly be settled, and accordingly, the amount will be accounted for in the Board's account in the current financial year.
7. The proposal of District Magistrate, Darjeeling regarding alteration of the location of one crèche in the land allotted by Mohanlal Division of Tirrihannah Tea Estate instead of Girish Chandra Tea Estate was placed was discussed and accepted. As such, it was decided that the updated list needed to be shared with the Board members along with the proceedings.

8. The following miscellaneous issues were discussed :-

- 1) Status Report of implementation of BOCW Act and welfare schemes framed thereunder up to July, 2024 was placed for kind perusal of the Board members. Thereafter, discussion was held on the expenditure incurred by the Board for the period from 01.02.2024 to 31.07.2024. A few non official members held that it was not possible to appreciate and understand the matter instantly. As such, it was decided that observation, if any, has to be submitted before the Board within a period of next seven days. Otherwise, it will be deemed to have been accorded *Post Facto* approval.
- 2) Proposal for reimbursement of the PF contribution of the construction workers deposited from 01.04.2020 to the date of attaining 60 years, who were registered under the erstwhile SASPFUW scheme was discussed. The Board members were suitably apprised regarding the issue and it was further resolved to disburse such claims (entire final payment claim of the beneficiary) initially from the end of the West Bengal Unorganised Sector Workers' Welfare Board (WBUSWW Board). The WBB&OCWW Board would reimburse such amount on quarterly basis to the WBUSWW Board. It was also noted that the detailed proposal was already placed before the Labour Department.
- 3) Refund of the wrongly credit to the Cess Fund from the following six agencies/authorities was discussed and approved :-
 - a) Rs. 13,464/- of Tamluk Highway Division;
 - b) Rs. 6,52,913/- of Jiaganj Azimganj Municipality;
 - c) Rs. 6,366/- of Singur Panchayat Samity;
 - d) Rs. 1,67,683/- for DPMU Darjeeling;
 - e) Rs. 39,624/- of Finance Officer Gangarampur,; and,
 - f) Rs. 91,011/- for BDO Swarupnagar.
- 4) It was noted that the Sanctioning Power of the various Authorities for incurring different expenditure was last discussed and enhanced in the 27th meeting of the Board held on 19.02.2016. Such enhancement accorded approval in the following manner :-

Any expenditure above Rs. 50,00,000/- is to be placed before the Hon'ble Chairperson of the Board for approval.

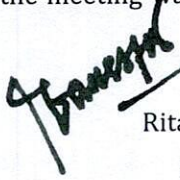
- 5) The Hon'ble MIC informed the members that the workers in the tea garden areas in the North Bengal region faced utter distress in the lean season of tea plantation. It was proposed that the WBB&OCWW Board will undertake a Pilot Project in selected Labour

Welfare Facilitation Centres (LWFCs) for **ensuring 100 days' work** to such workers - initially in the districts of Darjeeling, Kalimpong, Jalpaiguri, Alipurduar and Cooch Behar. Such workers would be engaged in various construction projects funded by the Board. The details of this scheme and the modalities will be drafted and discussed in due course.

- 6) Shri Ashok Ghosh, General Secretary, U.T.U.C. Central Committee & Invitee requested the Secretary, WBB&OCWW Board to finalize the issue of the proposed Guest House for the construction workers at Puri. The Hon'ble MIC, Labour Department advised the Secretary of the WBB&OCWW Board to publish a Notice of Expression of Interest (EOI) in the leading newspapers of West Bengal & Odisha for hiring (lease) of a 20 bedded Holiday Home / Guest House preferably with sea facing balcony and attached bath facilities.
- 7) The proposal for enhancement of professional fees of Sri Abhisek Pal, Senior Software Developer of the WBB&OCWW Board as per Finance Department Order No. 1086 – F(P2) dated 01.03.2024 from Rs. 30,000/- to Rs. 39,000/- as on 01.06.2024 along with payment of accrued arrear as applicable was discussed and approved.
- 8) The proposal for enhancement of remuneration of Sri Trishanu Bhattacharya, Contractual Clerk of the WBB&OCWW Board as per Order of the Finance Department Vide No. 1091 – F(P2) dated 01.03.2024 from Rs. 17,968/- to Rs 26,000/- w.e.f. 01.07.2024 (on completion of ten years of service) along with payment of accrued arrear as applicable was discussed and approved.
- 9) The prayer of Purna Chandra Das, Vill & P.O. – Uttar Gopal Nagar, P.S – Pathar Pratima, District – South 24 Parganas, regarding refund of Rs. 52,293/- on account of benefits received under the Beedi Housing Scheme, PM Kishan Nidhi and PFMS in the non-operative subscription account of erstwhile UBI (Now PNB) was placed for discussion. The board members accorded necessary approval for this purpose.
- 10) The issue of enhancement of vehicle charges in respect of all the constituent Regional Labour Offices for 8 days a month was raised and discussed. It was resolved that the matter needed further deliberations and may be placed in the subsequent meeting of the Board.
- 11) The vacancy of staff at various offices / LWFCs under different tiers, particularly in the post of Group 'D' was noted. The Hon'ble Minister-in-Charge, Labour Department that a comprehensive proposal may be moved for engaging Group 'D' on contractual basis from the end of the Labour Commissionerate seeking approval of the Finance Department routed through the Labour Department.

There being no other point to discuss, the meeting was ended with vote of thanks to and from the Chair.
