

Proceedings of the 46th Meeting of the WBB&OCWW Board held on 07.03.2025 (Friday)
at 01:00 P.M. in the Conference Hall, Labour Department, N. S. Buildings (12th Floor).
Block - A, 1, K. S. Roy Road, Kolkata - 700 001

The Hon'ble Minister-in-Charge, Labour Department took the chair and welcomed all present in the meeting. The meeting was presided over by Shri Ritabrata Banerjee, Chairperson, West Bengal Building & Other Construction Workers' Welfare Board (the Board) & Hon'ble MP, Rajya Sabha. He too welcomed all present and requested the Secretary of the Board to initiate agenda wise discussion. The list of the members, invitees and officials who attended the meeting is annexed herewith.

1. The Proceedings of the 45th Board Meeting held on 05.09.2024 and its Action Taken Report were discussed and confirmed.
2. Annual Accounts of the WBB&OCWW Board for the financial year 2023-24 was placed before the Hon'ble Board Members for adoption and approval. After discussion, Annual Accounts for the financial year 2023-24 was approved.

Shri Debanjan Chakrabarti, representative of C.I.T.U & member stated the issue of registration of BOCW in e-District Portal as well as BMSSY portal is creating difficulties. However, The Secretary, Board informed him that data transfer from the e-District portal was completed and the workers can now register themselves in B&OCW Scheme and BMSSY scheme through the single BMSSY portal. This process already started since 02.11.2023.

Shri Biplab Bhatta, representative of A.I.T.U.C. & member stated that the awareness fund was not properly utilized by different Regional Labour Offices (RLOs). Hon'ble MIC requested him to submit specific instances in writing in this regard so that those could be verified and cross checked.

Both Shri Bikash Ghatak, representative of I.N.T.U.C. and Shri Debanjan Chakrabarti representative of C.I.T.U held that advertisement related to cess collection and various benefits under the BOCW Act be made through television and FM radio. It was assured that the Board will take necessary steps in this regard through the leading newspapers. The Chairman of the Builders' Association of India expressed their intention to participate in such activities and was appreciated by the members present. A written proposal was required from that end to facilitate the matter.

3. Thereafter, it was informed to the Board members that the Tea Directorate is now under the administrative control of the Labour Department in place of the North Bengal Development Department (NBDD) and it will implement all the welfare activities / projects of the WBB&OCWW Board in the North Bengal region. Some of the creches and health centres were under construction by the NBDD and GTA in North Bengal region. Tea Directorate will now be responsible for overall supervision as well as maintenance of the projects, including selection of SHGs for creches, arranging for manpower of different categories for the health centres, procurement of all types of infrastructure (onetime items) for both creches and health centres, arranging for appropriate security for the health centres which are yet to be made operational but construction is complete etc. Fund for all such purposes will be requisitioned before the Board and the Board will do the

needful in due course.

4. The Tea Directorate received an unutilised fund amounting Rs. 35,52,81,847/- (Rupees Thirty-Five Crore Fifty-Two Lakh Eighty-One Thousand Eight Hundred and Forty-Seven) only after change of administrative control from the NBDD to the Labour Department. The Tea Directorate has Rs. 30,81,86,836/- (Rupees Thirty Crore Eighty-One Lac Eighty-Six Thousand Eight Hundred and Thirty-Six) only as balance, which also includes Rs. 3,29,81,788/- (Rupees Three Crore Twenty-Nine Lakh Eighty-One Thousand Seven Hundred and Eighty-Eight) only as security deposit. The Tea Directorate was allowed to incur relevant expenditure for the purpose of construction of Creches and Health Centres out of the said fund except security deposit amounting Rs. 27,52,05,048/- [Rs. 30,81,86,836/- minus Rs. 3,29,81,788/-]. Apart from this, the Tea Directorate needs additional amount of Rs. 37,75,69,000/- (Rupees Thirty-Seven Crore Seventy-Five Lac Sixty-Nine Thousand) only to complete the construction of 66 creches and 39 health centres on revised estimate. The revised estimate includes 3% contingency of which 1% will be retained by the Tea Directorate. The proposal for use of balance fund for construction work and allotment of additional fund was initiated at the end of the Labour Department and approved by Hon'ble HMIC too [vide e office file number - LABR-39011/1/2024-(DT)] (LABR) - Department of Labour]. Release of Rs. 37,75,69,000/- (Rupees Thirty-Seven Crore Seventy-Five Lac Sixty-Nine Thousand) only was approved.

The management of **Fulbari Patan, Darjeeling** expressed their inability to provide land suitable for construction of Creche. Suitable land is also not available at **Tumsong, Darjeeling**. As such, proposal for relocating **one Health Centre and one Creche at Nagrifarm Tea Garden, Sukhiapokhri Block, Darjeeling** was approved (revised list of creches and health centres are annexed). It was noted that the number of creches approved up to 46th meeting of the WBB&OCWW Board comes to 95 and the number of health centres up to 46th meeting of the WBB&OCWW Board stands at 55.

5. The proposal for Pension to the beneficiaries, who have submitted their contribution regularly for at least five years, but failed to pay their last contribution (being less than 12 months) was placed and approved. This is applicable for the beneficiaries who have submitted their contribution regularly in the last five years prior to the period under consideration. It was appreciated that such system, once put in place, will be helpful to cover more pensioners under the WBB&OCWW Board. Shri Biplab Bhatta, representative of A.I.T.U.C requested to consider the family pension of those beneficiary, who failed to renew continuously for five years and expired in the meantime. Shri Debanjan Chakrabarti representative of C.I.T.U also raised the issue for submission of the renewal form in hard copy in the LWFCs. The Hon'ble MIC directed that the application may be received in hard copy but those must be uploaded by the Collecting Agent / Self Employed Labour Organisers concerned in the portal within next seven days' time.

6. It was reported that the process of purchase of 14 photocopier machines, 394 desktop computer

sets, 413 scanner printers along with MS office, Security Software, UPS, 1 colour printer, 2 duplex scanner printer and 1 hard disc - for the Regional Labour Offices (RLOs) and Labour Welfare Facilitation Centres (LWFCs) and for the Board Office (as the case may be) through the GeM Portal could not be clinched thrice for various reasons despite best efforts. In view of the same, it was resolved that such purchase would be made through the Webel Technology Limited (WTL). The Board would take up the matter for procurement of these items with the WTL. However, WTL would do the needful following all extant financial rules and regulations prescribed for the purpose.

7. The Secretary, WBB&OCWW Board informed the Board members regarding the proposal received from the SBI for online collection of registration and subscription fees through the payment gateway of SBI and use of UPI mode for such collection. The subscription accounts of the Board are already maintained with the SBI. This module will be helpful for collection of the registration and subscription fees smoothly and the amount will be credited in the account of the Board instantly. Therefore, monitoring the matter both at RLOs and Board level will be rendered much easier. This proposal was further elucidated by Sri Shyamaprasad Kundu, Joint Labour Commissioner (P). The Board members welcomed this and approved the same. However, it was noted that HDFC Bank too has submitted a similar proposal. But it has been mandated by the Hon'ble Supreme Court of India to keep funds in nationalised bank only and hence could not be considered.

8. The Board exhibited Rs. 71.16 Lakh as Cess receivable on account of un-encashed cheques / DD from different employers towards Cess, **pending from 2010 to 2014**. As considerable time has elapsed, the chance of realisation of this Cess is very remote. The Audit advised the Board to take necessary steps either to recover the amount or adjust the receivable in the accounts. The Secretary, Labour Department held that the Board should once again take up the matter of recovery of the amount. It was decided that the Board will move to the employers/authorities for recovery of the receivable amount of cess. If no tangible result yielded in spite of such initiative, it would then be placed in the subsequent meeting of the Board for doing the needful as per Audit observation.

9. The proposal of the Tea Directorate, Labour Department (Hard File No. 55/Labr/TD/1E-03 Dated 28.02.2025) seeking in principle administrative and financial approval of the Board for purchase of 54 ambulances for the health centres constructed by the WBB&OCWW Board was discussed. It was noted that the matter was already approved by the Hon'ble MIC, Labour Department. The Tea Directorate proposed a budget of Rs. 7,56,00,000/- (Rupees Seven Crore Fifty-Six Lac) only for purchase of 54 ambulances and recurring expenses of Rs. 1,18,00,728 (Rupees One Crore Eighteen Lac Seven Hundred and Twenty-Eight) only for 1 year. The total amount requisitioned is Rs. 8,74,00,728/- (Rupees Eight Crore Seventy-Four Lac Seven Hundred Twenty-Eight) only. Tea Directorate will follow relevant extant Rules for the purpose. However, actual purchase should be made in the timeline matching with the operationalisation of such health centres. This proposal was approved.

10. The other proposal of the Tea Directorate, Labour Department (Hard File No. 54/Lab/ TD/WF-01/25 Dated 28.02.2025) seeking in principle administrative and financial approval of the Board for purchase of 11 buses amounting Rs. 2,63,34,000/- (Rupees Two Crore Sixty-Three Lac Thirty-Four Thousand) only for the school going children of the construction workers in Alipurduar and Jalpaiguri districts was discussed. For running these 11 buses, the cost of wages of the drivers and conductors for one year has been estimated by the Tea Directorate as Rs. 24,03,852/- (Rupees Twenty-Four Lac Three Thousand Eight Hundred and Fifty-Two) only whereas the cost of fuel as estimated stands at Rs. 27,45,600/- (Rupees Twenty-Seven Lac Forty-Five-Thousand and Six Hundred) only. Therefore, total cost involved for components as stated above comes to Rs. 3,14,83,452/- (Rupees Three Crore Fourteen Lac Eighty-Three Thousand Four Hundred Fifty-Two) only. As usual, all relevant extant Rules for the purpose would have to be followed by the Tea Directorate. This proposal was approved too.

11. The expenditure incurred by the Board for the period from 01.08.2024 to 31.01.2025 was discussed and post facto approval was accorded.

12. The budget as received from Executive Engineer-1, PWD Department, Kolkata West Division for repairing and renovation of WBB&OCWW Board office at Block – C, N. S. Buildings (4th Floor), Kolkata – 700 001 amounting Rs. 2,18,785/- (Rupees Two Lac Eighteen Thousand Seven Hundred Eighty-Five) only was discussed and the payment to be made was accorded approval.

13. It was observed that the Hon'ble Supreme Court of India, Comptroller & Auditor General of India and the Ministry of Labour & Employment, Government of India have time and again advised the State Social Security Boards to conduct social audit of the schemes run by them. As desired by Hon'ble Minister-in-Charge, Labour Department, Government of West Bengal, Social Audit Unit (SAU) of the West Bengal State Rural Development Agency (WBSRDA) under the P & RD Department, West Bengal, was approached for conducting social audit of the WBB&OCW Welfare Board. Five Regional Labour Offices (Malda, Kandi, Uluberia, Tamluk and Diamond Harbour) have been identified for this purpose on the basis of number of benefits (Natural Death, Accidental Death, Disability, Provident Fund & Pension) disbursed during the FY 2024-2025 (up to 31.01.2025). The estimated budget submitted by the Director, SAU, WBSRDA is Rs. 52,47,080/- (Rupees Fifty-Two Lac Forty-Seven Thousand and Eighty) only. It was further be noted that 50% of the fund to be provided to the Director, SAU, WBSRDA in advance before starting of the project. This was approved.

14. The miscellaneous issues as stated below were also discussed:-

- i) Regarding Internal Audit, the Labour Commissioner, West Bengal will float a tender for engagement of an agency for conducting internal audit of three Boards, viz, the WBB&OCWW Board, WBUSWW Board and WBTWSSS. The WBB&OCWW Board would be designated as the Nodal Board, and initially, payment relating to the auditor fees and other miscellaneous expenses will be released from this Board. Subsequently, such expenditure would be proportionately met out of the contingent fund of the WBB&OCWW Board, WBUSWW Board and WBTWSSS in the ratio of 40%, 30% and 30% respectively.

- ii) It was decided that for effective management of pension system, claims will have to be submitted to the respective LWFCs within two (2) years from the date of superannuation (attaining 60 years of age) / date of death of the beneficiary positively.
- iii) The case of Sri Alope Kumar Mishra (Registration number CP4402007045, Date of Registration 21/09/2011 and SSIN-244020022853) of Daspur-II Block, Ghatal Sub-Division, District - Paschim Medinipore was discussed after this. It was noted that he was not granted pension under BOCW Welfare Scheme since there was a "less payment" of a sum of Rupees Eighty during the period from June, 2012 to March, 2013. However, Sri Mishra was allowed to continue as beneficiary for the next 9 years, i.e., from April 2013 to March 2022. As a special case, the pension of Sri Alope Kumar Mishra was accorded due approval by the Board.
- iv) The issue of refund of wrongly deposited cess was discussed and refund was approved for the following cases :-
- a) Manbazar - II Panchayat Samity amounting Rs. 17,500/-;
- b) KEC International Ltd. amounting Rs. 2,55,900.68 and Rs. 3,72,146/- respectively;
- c) Canara Bank amounting Rs. 466/-;
- d) Balurghat Municipality amounting Rs. 79,171/-; and,
- e) National Institute of Biomedical Genomics, Kalyani amounting Rs. 18,14,158/-.
- v) Post Facto approval for payment of professional fees of Sri Abhisek Pal, Senior Software Developer of the Board from 05.12.2024 to 04.12.2025 and payment of remuneration of Sri Trishanu Bhattacharya, Contractual Clerk of the Board from 01.01.2025 to 31.12.2025 was placed in the meeting and approved.
- vi) Regarding Income Tax, it was intimated that a Writ Petition (WPA-4009 of 2024) has been filed before the Hon'ble High Court, Calcutta challenging the rejection order passed by the CBDT for granting exemption U/S 10(46) of the Income Tax Act, 1961 to the Board and the matter is currently pending before the Court. Apart from this, an appeal against the order of the CIT has been filed before the Income Tax Tribunal for depositing income tax to the tune of Rs 258,56,14,034/- for want of exemption granted U/S 10(46) of the Income Tax Act, 1961 pertaining to the assessment years 2017-18 and 2018-19. Similar proceedings for the financial year 2022-23 have also been initiated. To avoid such proceedings and as advised by the Senior Advocate already engaged for the purpose, the Board is in the process of filing an interlocutory application before the Hon'ble High Court, Calcutta shortly.
- vii) The Life Insurance Corporation of India has submitted a proposal regarding processing of pension claims through purchase of annuity. The Board members welcomed the proposal and it was decided that the LIC will be asked to present the matter at a subsequent date.
