Proceedings of the 47th Meeting of the WBB&OCWW Board held on 24.06.2025 (Tuesday) at 04:00 p.m. in the Conference Hall, Labour Department, N. S. Buildings (12th Floor), Block - A, 1, K. S. Roy Road, Kolkata - 700 001

The Hon'ble Minister-in-Charge, Labour Department took the chair and welcomed all present in the meeting. The meeting was presided over by Shri Ritabrata Banerjee, Chairperson, West Bengal Building & Other Construction Workers' Welfare Board (the Board) & Hon'ble MP, Rajya Sabha. He too welcomed all present and requested the Secretary of the Board to initiate agenda wise discussion. The list of the members, invitees and officials who attended the meeting is annexed herewith.

1. The Proceedings of the 46th Board Meeting held on 07.03.2025 and its Action Taken Report were discussed. Shri Dilip Bhattacharya, representative of A.I.U.T.U.C. & Member raised his reservation against the manner in which many SLOs were working at the field level. Shri Ashok Ghosh, General Secretary, U.T.U.C. Central Committee & invitee and Shri Biplab Bhatta, representative of A.I.T.U.C. & Member also raised concern against the functioning of many SLOs. Sri Biplab Bhatta suggested that the Bangla Sahayata Kendra (BSK) may be integrated with the BM-SSY online services. The Secretary, Board informed that this matter of integration is already under consideration at present.

Thereafter, Shri Debanjan Chakrabarti, representative of C.I.T.U. & Member, sought clarification of point no 4 and point no 8 of the proceedings of the 46th Board Meeting related with fund received by the Tea Directorate from North Bengal Development Department (NBDD). The Hon'ble MIC, Labour Department and Secretary, Board explained in detail about the scope of work of the Tea Directorate after it has come under the Administrative Control of the Labour Department and the funds to be utilized by the Tea Directorate in relation to the BoCW Schemes. It was decided that the contact details of the authorities of Tea Directorate will be made available to the Board Members and website of the Labour Department, so that stakeholders concerned may get in touch with them if needed. The Secretary Board informed of the three authorities which had responded to letters who had issued cheques / DDs for depositing the cess but the same was not received in the account of the Board due to various reasons (as stated in ATR under Annexure – B).

The concern raised by Shri Debanjan Chakrabarti further raised issues regarding non-payment of cess by some big projects in and around Kolkata was noted. It was resolved that the Hon'ble MIC assured that he will take up the issue with the Hon'ble MIC, UD & MA department from his end in due course.

After thorough deliberation, the proceedings of the 46th Board Meeting and its action taken report was duly approved.

2. As per agenda note under serial number 2, the discussion of providing Pucca Houses as per BAY guidelines was initiated by the Secretary of the Board. He referred to the provision under Rule 277 of the West Bengal Building and Other Construction Workers' (RE & CS) Rules, 2004 for providing loans and advances up to Rs. 50,000/- to registered construction workers for construction of a house. It was informed that the

WBB&OCWW Board intends to provide housing scheme for the eligible homeless registered construction workers as per the guideline of **Bangla Awas Yojona (BAY)** as implemented by the P & RD Department & UD & MA Department. He also informed that **96,000** beneficiaries are yet to receive financial assistance for building pucca house under BAY, who are eligible for such scheme and registered with the BOCW Board. The total cost involvement for these 96,000 beneficiaries is approximately Rs. **1100 crore.** Shri Debanjan Chakrabarti protested against such proposal. Shri Dilip Bhattacharya expressed his concern about those workers who didn't possess their own land. Similar query was also received from some other Board members. Hon'ble MIC informed the Members that the issue of landless workers may be considered in a different manner. Shri Partha Pratim Sarkar informed that only a few workers received the benefit of BAY till date. This scheme will be implemented through the P&RD and UD&MA Department(s), as the case may be. The Board will release fund to these departments in phased manner for such purpose. The matter was **accorded approval** in **principle**.

Shri Debanjan Chakrabarti also requested the Hon'ble MIC for publication of a compendium of all the orders and guidelines issued in connection with making application for various types of financial assistances under the scheme as it will be helpful for better understanding of the scheme to all stakeholders and was accepted by the Board members.

- 3. Deliberations were also held regarding according benefit to the registered construction workers in regard to **Health Scheme as per Swasthasathi and various benefits being provided for education**. The process as stated in case of BAY above would be followed in these two matters too with the Government Department concerned. The Board release fund to these departments based on their requisition and **both the matters were accorded approval in principle**.
- 4. The Chairperson, Board pointed out to the need for **digital empowerment of the children of the construction workers** and announced that a study report on the same is to be placed in the subsequent meeting of the Board. The issue of **training for the construction workers** was also discussed in brief.
- 5. The in principle Administrative Approval and Financial Sanction for purchase of 54 ambulances for the health centres constructed by the WBB&OCWW Board approximately amounting Rs. 8,74,00,728/- was accorded in the 46th meeting of the WBB&OCWW Board held on 07.03.2025 including purchase, maintenance cost, other incidental cost, wages and fuel cost for one year was recalled. This was ratified in the 18th meeting of the Tea Advisory Council too held on 12.04.2024. Now, that the number of health centres has increased to 55, ambulances need to be purchased by the Tea Directorate will be 55 and in the timeline matching with the operationalisation of such heath centres.

6. It was recalled that in principle Administrative Approval and Financial Sanction for purchase of 11 buses for the school going children of the construction workers in the alpaiguri and Alipurduar districts amounting Rs. 3,14,83,452/- was accorded in the WBB&OCWW Board held on 07.03.2025 including purchase,

maintenance cost, other incidental cost, wages and fuel cost for one year. This too was discussed and approved in the 18th meeting of the Tea Advisory Council held on 12.04.2024. These buses need to be purchased by the Tea Directorate as already approved and deployed as per routes proposed by the District Magistrates concerned.

- 7. The proposal for construction of 283 toilets for female construction workers in North Bengal region was accorded in principal approval. It was recalled that this it was already approved in the 18th meeting of the Tea Advisory Council held on 12.04.2024 that at present 26 such facilities would be taken up in regard to the hilly regions of the Darjeeling district. The Tea Directorate would obtain budget estimate from the PWD and vetting would be done by the GTA thereafter. The proposal was approved and detailed budget will be placed in subsequent meeting.
- 8. The Board members were apprised that the authority for sanctioning pension application under Rule 276 of the BOCW (RE & CS) Rules, 2004 was delegated to the Assistant Labour Commissioner posted at the Regional Labour Offices for speedy disposal. Also, online Application of Pension through BMSSY Portal has been started with effect from 03.06.2025. Both these issues were placed before the Board members and accorded post facto approval. However, Shri Biplab Bhatta and other members expressed their concern regarding verification of the pension claims smoothly at RLO level due to non-availability of clerical staff. The Secretary, Labour Department assured the Board members that the process of sanctioning pension delegated at the RLO level will be regularly monitored. He even informed all the members that a large number of pending claims under BMSSY was disposed by the officers of the Labour Commissionerate through a special drive and he also requested the Board members to take the feedback from the ground level.
- 9. Thereafter, Separate Audit Report of the West Bengal Building & Other Construction Workers' Welfare Board for the financial year 2022-23 was placed before the Hon'ble Board Members by the Controller of Finance and the Chief Account Officer of the WBB&OCWW Board for adoption and approval. After threadbare discussion, the SAR was approved by the Board members.
- 10. The Board members were informed of taking possession of the Hostel /Transit Accommodation-cum-Training Centre at the 3rd floor of the Shramik Bhawan at Berhampore, Murshidabad. This was approved in the 44th meeting of the WBB&OCWW Board held on 13.02.2024. It was reiterated that this facility will be helpful for transit of the workers at the time of their migration to the worksite, as well as for imparting training through the employment directorate to the construction workers. The Board members expressed their eagerness to visit the Hostel/Training Centre. It was decided that the Secretary Board will inform the members regarding the tentative schedule for such visit in due course.

The proposal of formal inauguration of the Hostel /Transit Accommodation-cum-Training Centre and purchase of various items was approved. The Board will take further action in this regard in due course.

11. The status of the creches, health centres and guest house(s) were placed before the Board members for information and discussion. A few Board members enquired



specifically about the status of the Guest House that is supposed to come up at Puri, Odisha. The Chairman himself briefed of the bottlenecks being faced.

- 12. The miscellaneous issues as stated below were also discussed and ratified:
 - a) Status Report of implementation of BOCW Act and welfare schemes framed thereunder up to 31st May, 2025.
 - b) Post Facto approval of the expenditure incurred by the Board for the period from 01.02.2025 to 31.05.2025. This includes an amount of Rs. 15,02,011/- for observance of International Labour Day at Ramleela Maidan, Kolkata on 01/05/2025 in connection with participation of a big number of building & construction workers.
 - c) Refund of wrongly deposited Cess to three authorities, i.e. i) Executive Officer, Nabadwip Panchayat Samity of Rs. 2,21,030/-; ii) BDO Amdanga of Rs. 1,80,800/- and iii) Project Director, NHAI, PIU Malda of Rs. 4,13,32,890/-.
 - d) Toll Free Help Line Number of Labour Department, i.e. Shramik Sathi (1800 103 0009) started functioning with effect from 26.04.2025. The payment for help line to be made from the WBB&OCWW Board as decided by the Labour Department.
- e) Correction of error in Cash and Bank balance (opening) Schedule 8D as per Audit Enquiry Requisitions vide AENQ-7658474 was accorded approval.
- f) Pension claim of Shri Chandan Kumar Dhar, a BOCW pension applicant from Cooch Behar Municipality under Cooch Behar RLO was duly approved by the Board members as a special case.
- g) The Writ Petition filed before the Hon'ble High Court, Calcutta regarding exemption u/s 10(46) of the Income Tax Act, 1961 for the Assessment Years from 2016-17 to 2020-21 and the case is under trial yet.
- h) Another Writ Petition regarding exemption u/s 10(46) of the Income Tax Act, 1961 for the Assessment Years from 2021-22 to 2025-26 has been filed before the Hon'ble High Court, Calcutta and is pending disposal too.
- i) The case on RTI filed before the Hon'ble High Court, Calcutta by one Sri Patit Hari Basu has been dismissed.
- j) In a case of Arbitration arising out of AP(COM) No 868 of 2024 in the matter of S. K. Samanta & Company Limited-vs-Eastern Coalfields Limited and Others regarding wrong deduction of Cess, the Board has been exempted from appearing in the Arbitration proceedings. However, the issue of legality of deduction of Cess remains to be decided yet which will be a matter to be fought by and between the parties concerned.

There be no other point to discuss, meeting was ended with vote of thanks to and from the Chair.
