**Sub.:** Rates of daily wages of daily-rated workers under the Government whose wages are not regulated by any of the Statutory provisions like the Minimum Wages Act, etc.

Sir,

This is to inform you that the rates of daily wages for the workers as mentioned above were enhanced under the Government of West Bengal, Finance Department, Audit Branch Memo No. 3300(65) dated 04.05.2009 and thereafter under Memo Nos. 10900-F(P) dated 09.12.2009, 2580-F(P) dated 06.04.2010, 10850-F(P) dated 23.11.2010, 11080-F(P) dated 12.12.2011, 10615-F(P) dated 31.12.2012, 8840-F(P2) dated 16.12.2013, 143-F(P) dated 09.01.2015, 8430-F(P2) dated 14.12.2015, 18-F(P2) dated 02.01.2017, 5724-F(P2)/ N/2A-2/97 (pt. I) dated 12.09.2017. Now, under Memo No. 4037-F(P2) dated 21.06.2018 the existing rates of wages have further been increased by Rs. 53/- (Rupees fifty three) only w.e.f. 01.01.2019.

Hence the daily rates of wages would now be as follows:
