In exercise of the power conferred by Sub-Section 25 of the West Bengal Shops and Establishment Act, 1963 (West Bengal Act, XII of 1963), the Governor is pleased hereby to make, after previous publication as required by Sub-section (I) of section 25 of the said Act the following amendments in West Bengal Shops & Establishments Rules, 1964 (here-in-after referred to as the said Rules)

AMENDMENT

In the said rules, -
